#### **Marketing**

# • Virginia Campground Directory

- Only VCA member campgrounds receive a listing and the ability to advertise in the Virginia Campground Directory. In 2021, VCA is producing three digital editions of the directory: spring, summer, & fall. The digital directory will be advertised through Facebook, Virginia Campgrounds Website, email blasts, Mid-Atlantic AAA, Virginia Tourism's "Virginia is for Lovers" website, Blue Ridge Outdoors, RV Shows, and enhanced Google Search Engine options.
- The 2020 printed directory will continue to be distributed until gone. Once all 2020 directories are distributed, the VCA Board will discuss printing the 2021 directory. This will depend on time of year and distribution costs.
- VCA normally attends a minimum of 6 RV shows, however, these shows have been cancelled for 2021
